FIELD RESPONSE LOG CATEGORIES

Discussion:

Responses to incidents involving horses fall into eleven general categories that are abbreviated in order to make the spreadsheet workable. This Procedure Guide is intended to provide guidance for accurately categorizing responses as may be practicable.

General Parameters:

Categories marked should reflect the primary or most exigent reason for the call-out. A second entry (on a separate line) may be warranted in certain circumstances. A typical example could be horses in traffic (Horse Hwy) where horses are removed, but a separate action is required to repair infrastructure. If a simple fence repair or gate closure is accomplished during the removal of animals, a simple log note would suffice and a separate entry would not be required.

The proper category should be marked with the numeral "1" so the sheet will tally correctly.

Category Definitions by Heading:

Inj. Horse:

These are incidents involving sick or injured horses where upon arrival there is a reasonable appearance that evaluation and/or treatment may reasonably be required.

Horse Hwy:

Any incident where the primary issue involves horses in traffic on any public right-of-way. (By definition, "highway" means the entire width between the boundary lines of every way maintained by a public authority when any part of such way is open to the use of the public for purposes of vehicular traffic. (NRS 482.045)

Equestrian:

Any incident that involves a circumstance where a person, mounted or leading, is associated.

Infrast:

Infrastructure means any action, other than an immediate remedy, that requires a response to secure or repair fencing, gates and any other device intended to keep horses or livestock off roadways and/or out of areas in which horses or livestock should be excluded.

Entrapmt:

Any incident in which a horse or other livestock has become ensnared or entrapped, including incidents where it is reasonably sure that such occurred, but the animal self-extricated.

Relocatn:

An operation that involves the actual capture and relocation of horses or other livestock to a more appropriate location, involving more than merely pushing animals out of an undesirable location.

Mstk. Alm:

A mistaken alarm (mistaken report) of a condition that on investigation did not actually exist.

Em. Transp:

The emergency transportation of a horse or other livestock to a veterinary facility or holding where a veterinarian would be attending.

Invest:

Investigations involve collecting information and data on a variety of incidents that could include deceased horses, possible illegal capture of horses, vandalism, criminal acts, etc.

Evac:

Evacuation operations of any type, customarily due to floods or wildfires.

Other:

Any activity not otherwise classified, such as transporting a horse back from Comstock, taking a deceased horse to the landfill or other approved location, assisting a veterinarian,

Animal Classification Categories:

These classifications simply define whether the animal(s) involved in the incident were Virginia Range or not.

VRE:

(From the original Virginia Range Estray designation,) a Virginia Range horse or horses.

OTH:

Any non-Virginia Range animal
